The failure to communicate the requested data results in the application of the penalty to the jointly and severally liable (owner, renter, etc.) required by art. 126 bis, paragraph 2, of the Code of the Road and additional costs of assessment and notification.

**The signature of the person indicated as the driver fulfills the obligation of the infringement notification.** In the case the communication does not contain the driver's signature (if a different person from the owner / jointly and severally liable), he will be notified the infringement notice with the penalties required by the rule infringed and additional costs of assessment and notification.
